And after approval of the Executive Council;

have promulgated the following Resolution:

Article (1)

The schedules attached to this Resolution, including fees of services and functions conducted by Department of Economic Development in implementation of legislations regulating competences thereof shall be approved. The Department of Economic Development shall monitor the impact of implementing such fees on economy and business environment and propose amending them, where necessary and amendment shall be issued by a resolution from the Executive Council.

Article (2)

Each provision in previous resolution contradicts with provisions of this Resolution shall be repealed.

Article (3)

This Resolution shall come into force as date of its promulgation and be published in the Official Gazette.
